## A guide to using BPAY

For existing investors making additional investments in Tura Capital Global Small & Mid Cap Fund.

#### Who can use BPAY®?

Existing investors can use BPAY if they wish to add to a fund they are already invested in. An Additional Application Form must also be completed and returned to Apex Funds Services – Unit Registry.

New investors cannot currently use BPAY to make an initial investment.

## How to use BPAY®?

Existing investors can use BPAY if they wish to add to a fund they are already invested in. An Additional Application Form must also be completed and returned to Apex Funds Services – Unit Registry.

## Simply follow the below steps:

- 1. Contact your bank or financial institution to confirm you can use BPAY to make a payment from your cheque, savings, debit or transaction account.
- 2. Access this BPAY facility set up by your bank or other financial institution via telephone or their internet banking site.
- 3. Enter the relevant Biller Code for the fund you wish to invest in. These are outlined below for your information.

- 4. Enter your 16-digit Customer Reference Number (CRN) this is different to your Investor Number.
- 5. Enter the amount you wish to invest.
- 6. Record your receipt number as proof of the transaction. Please keep this for your personal records. The fund's administrator, Apex Fund Services will send you a transaction confirmation within 5 business days after the application monies are received into the fund's bank account.

## Some things to remember

- The minimum amount for an additional investment is \$5,000.
- Please complete and submit an Additional Application Form in addition to making the BPAY® payment.

## Who can use BPAY®?
