Investment philosophy and process

Tura Capital believes a focus on quality will enhance returns in global small and mid-capitalisation companies, when combined with a thorough valuation overlay. Tura Capital seeks to identify good quality businesses that are mispriced by overlaying Tura Capital's quality filter, referred to as the 'quality lens', with a strong valuation discipline.

Tura Capital's security selection process has a strong bottom up discipline and focuses on buying quality businesses at reasonable prices. The portfolio construction process is influenced by a top down economic appraisal and also considers the risk characteristics of the portfolio such as security and sector correlations. The investment strategy of the Fund is intended to result in a portfolio that is high conviction and invests for the medium to long term.
